

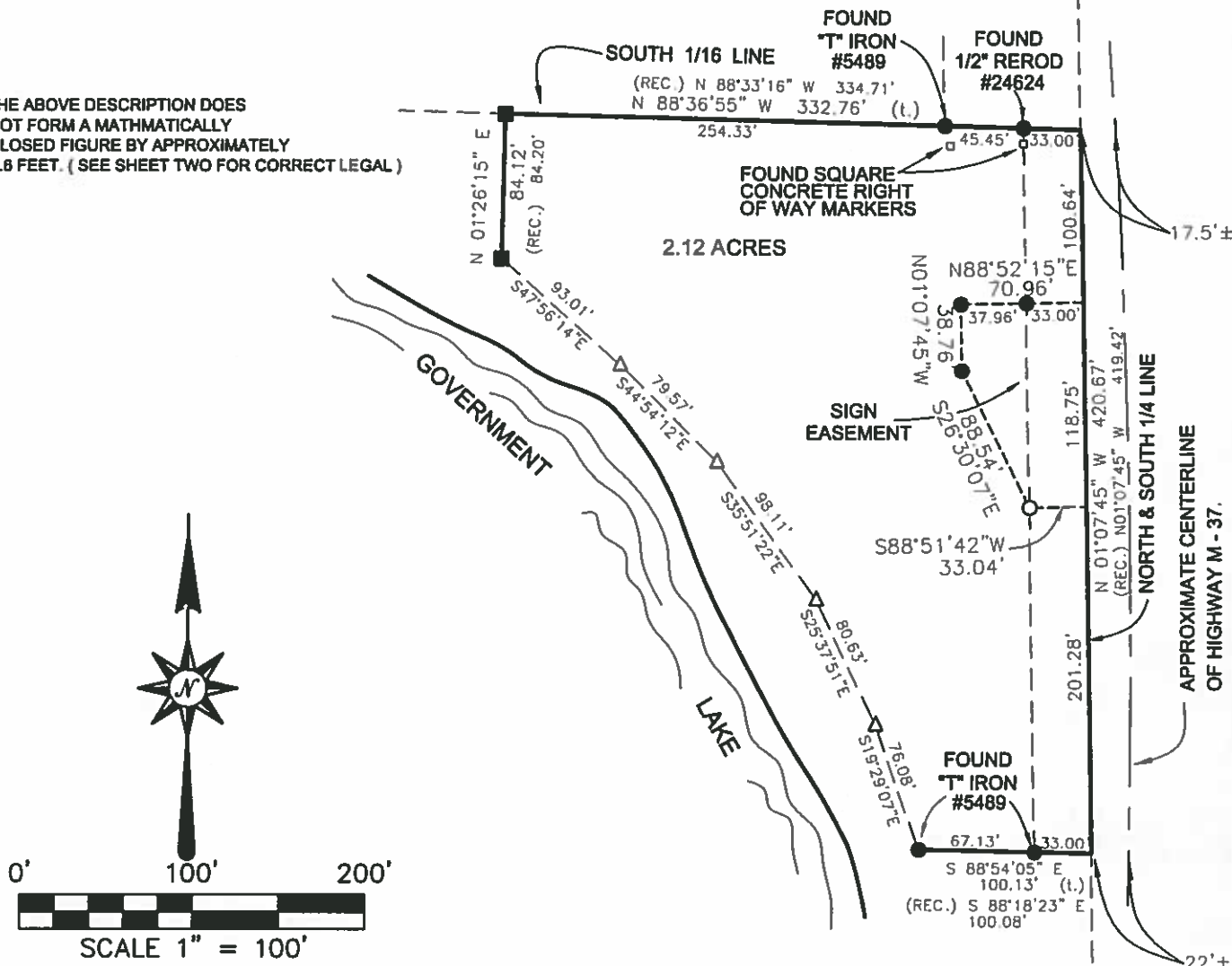

LEGAL DESCRIPTION FURNISHED: Part of the South-half (S. 1/2) of the Southwest Quarter (S.W.1/4) of Section Twenty-seven (27), Township Eighteen (18) North, Range Thirteen (13) West, described as: Beginning at a point on the North and South Quarter line of said Section that is N01°07'37"W along said Quarter line 878.66 feet from the South Quarter corner of said Section; thence N01°07'37"W along said Quarter line 419.42 feet to the South 1/16 line of said Section; thence N88°33'16"W along said South 1/16 line 334.71 feet to the East line of the plat of Government Lake; thence S1°26'15"W along said Plat 84.20 feet to the shore of Government Lake; thence S59°00'50"E along said shore 151.44 feet; thence S23°11'06"E along said shore 287.88 feet; thence S88°18'23"E 100.08 feet to the point of beginning.
