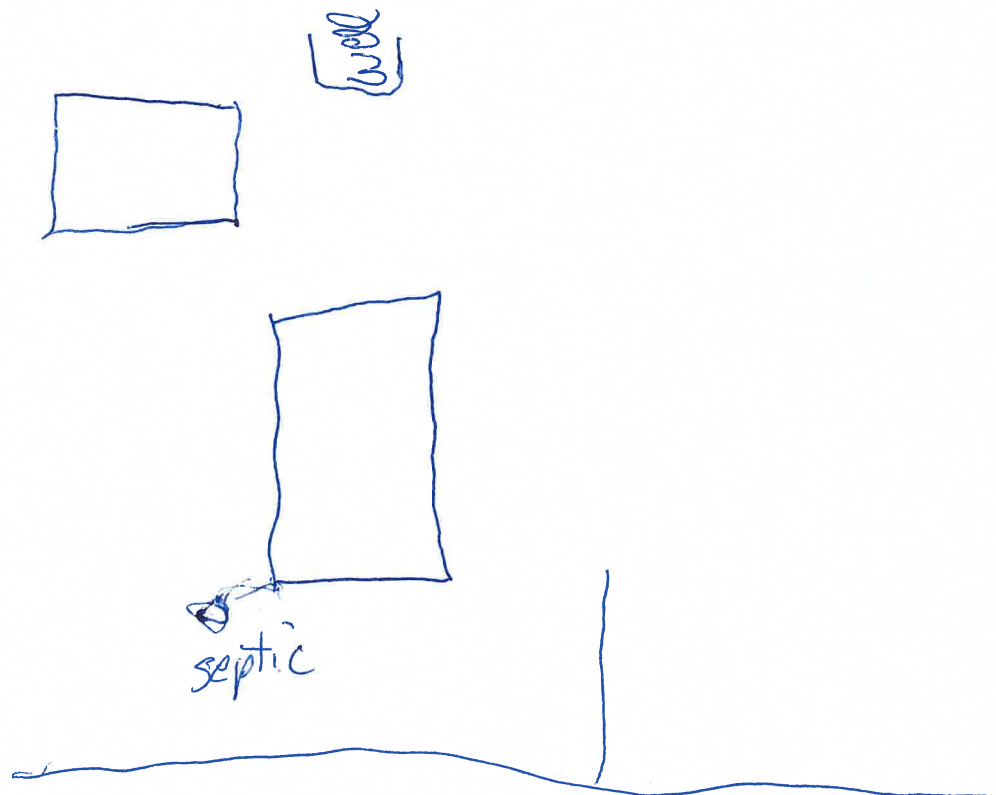
Septic, Drain Field, Well, and General Property Sketch
