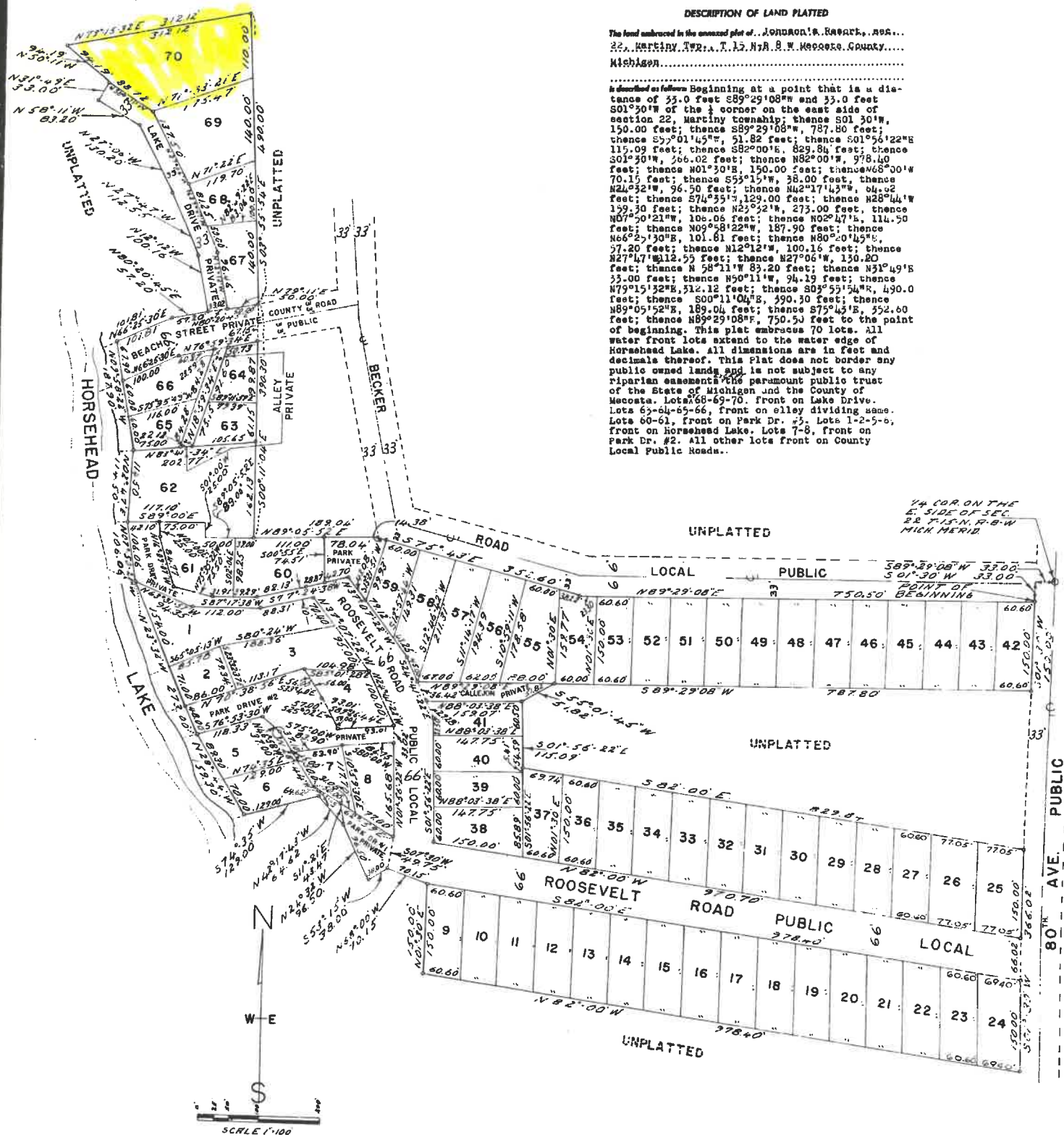

DESCRIPTION OF LAND PLATTED

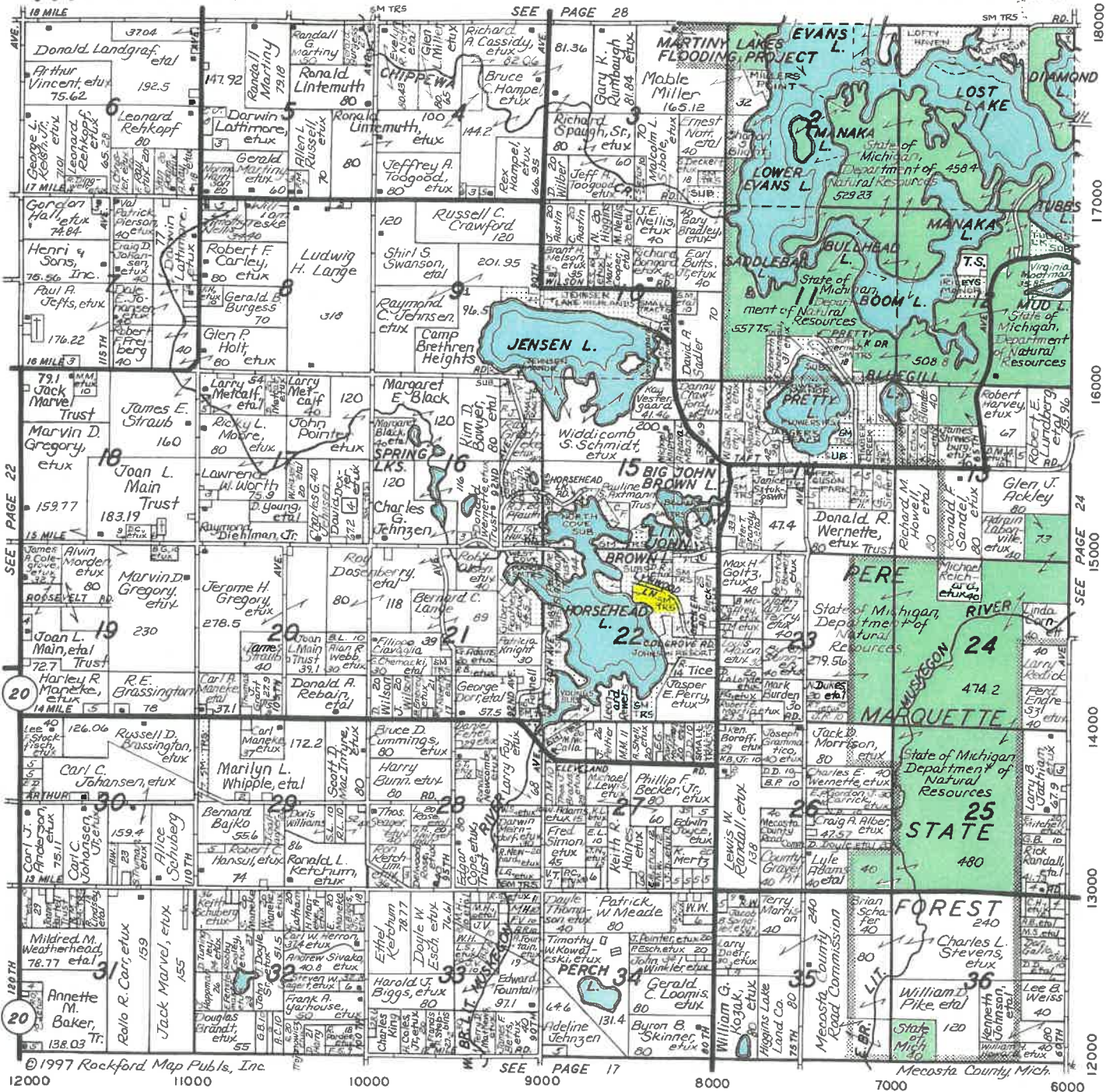
The land embraced in the annexed plat of J. JOHNSON'S RESORT, ...
